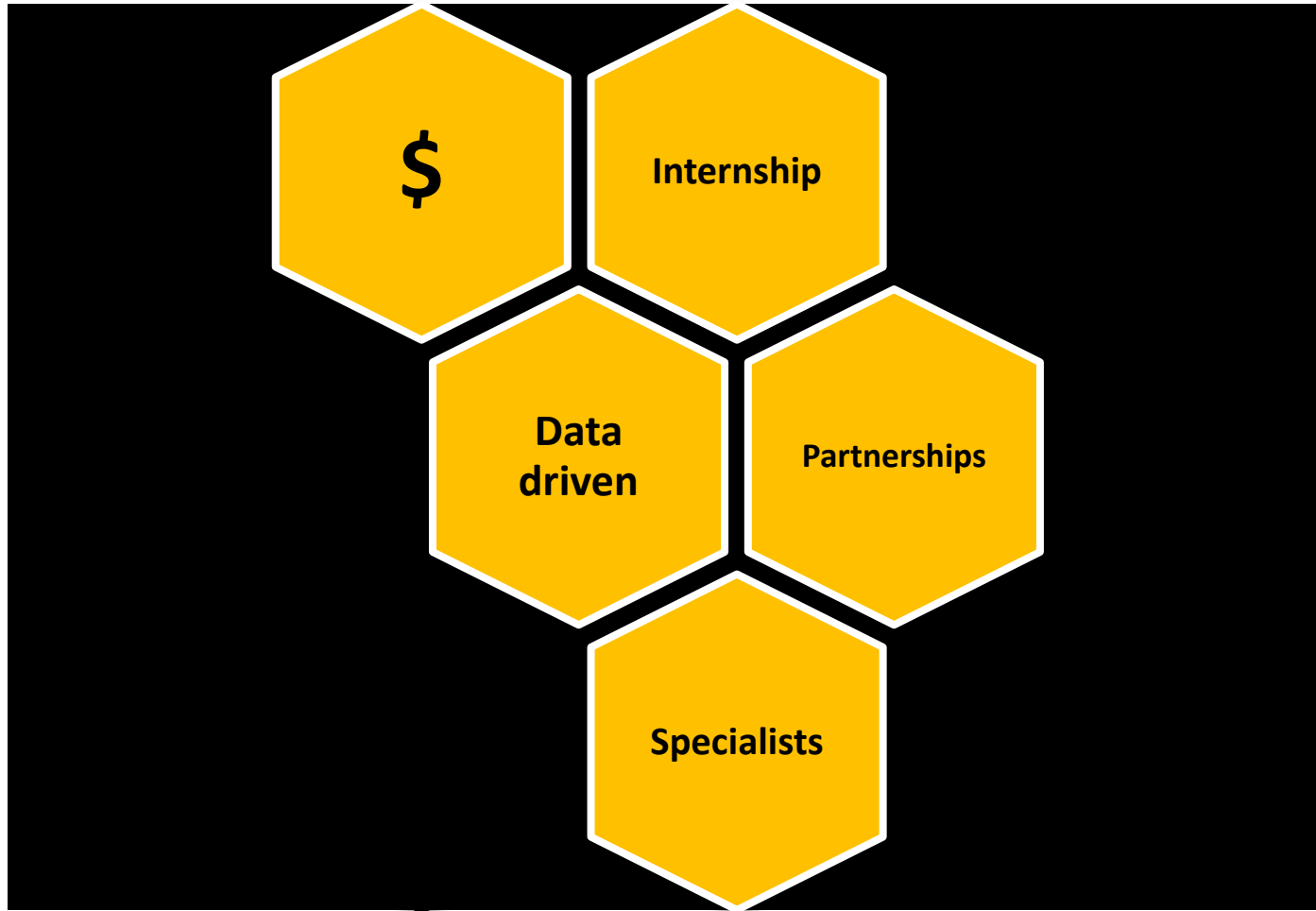

Campus Employment

- Meets interest or needed skill*
- Up to 10 hours/ week- Fall and Spring
- Paid at or above minimum wage
- Goal Setting
- Mid and final evaluations
- Individualized supports

Internship

Internship:

- Final semester
- 80- 100 hours
- Interest driven
- Paid or unpaid
- Job coach
- Evaluations
- Coursework targeting 21st Century Workplace skills

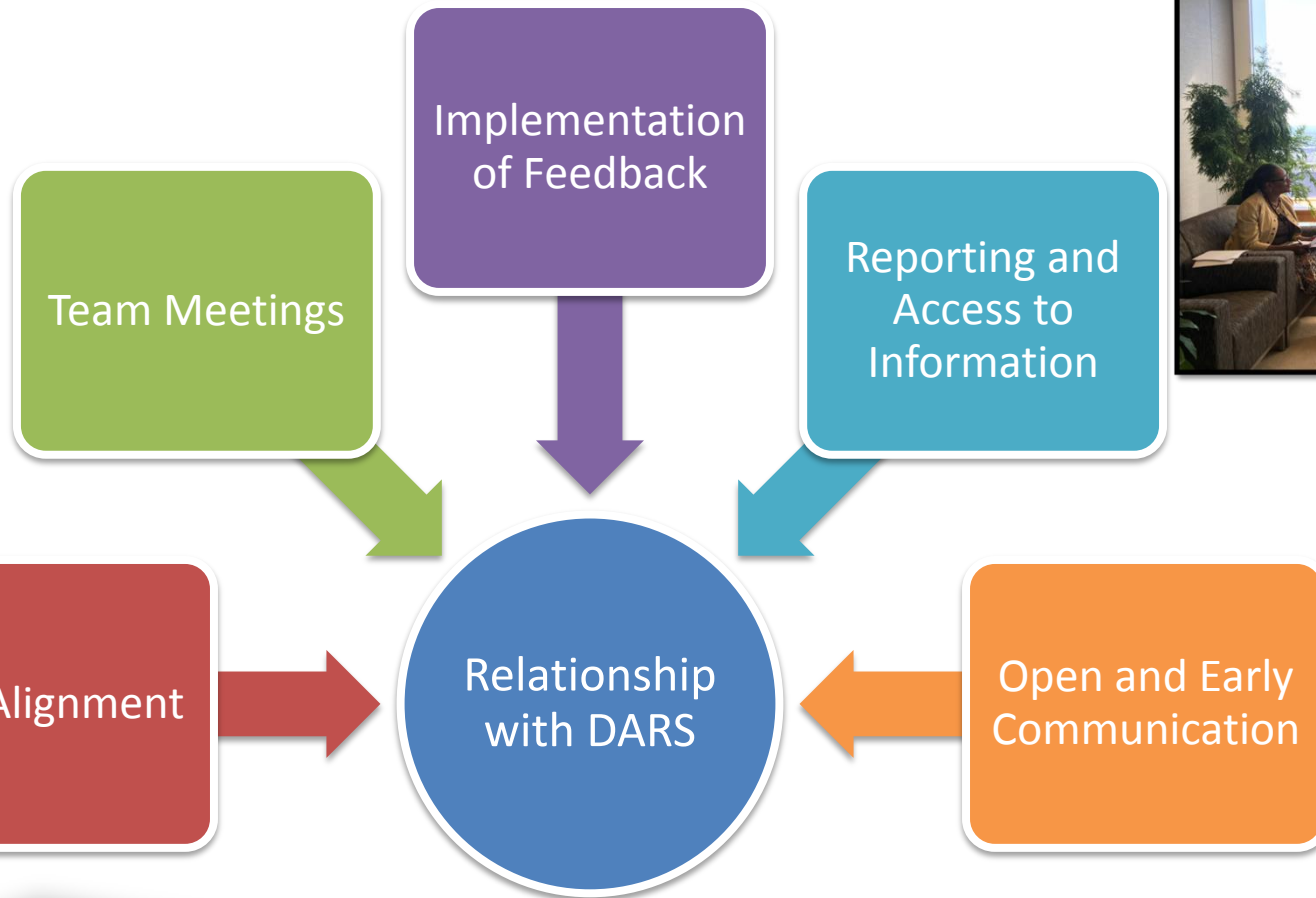

- Reduce program length for an expedited, cost-effective pathway to careers

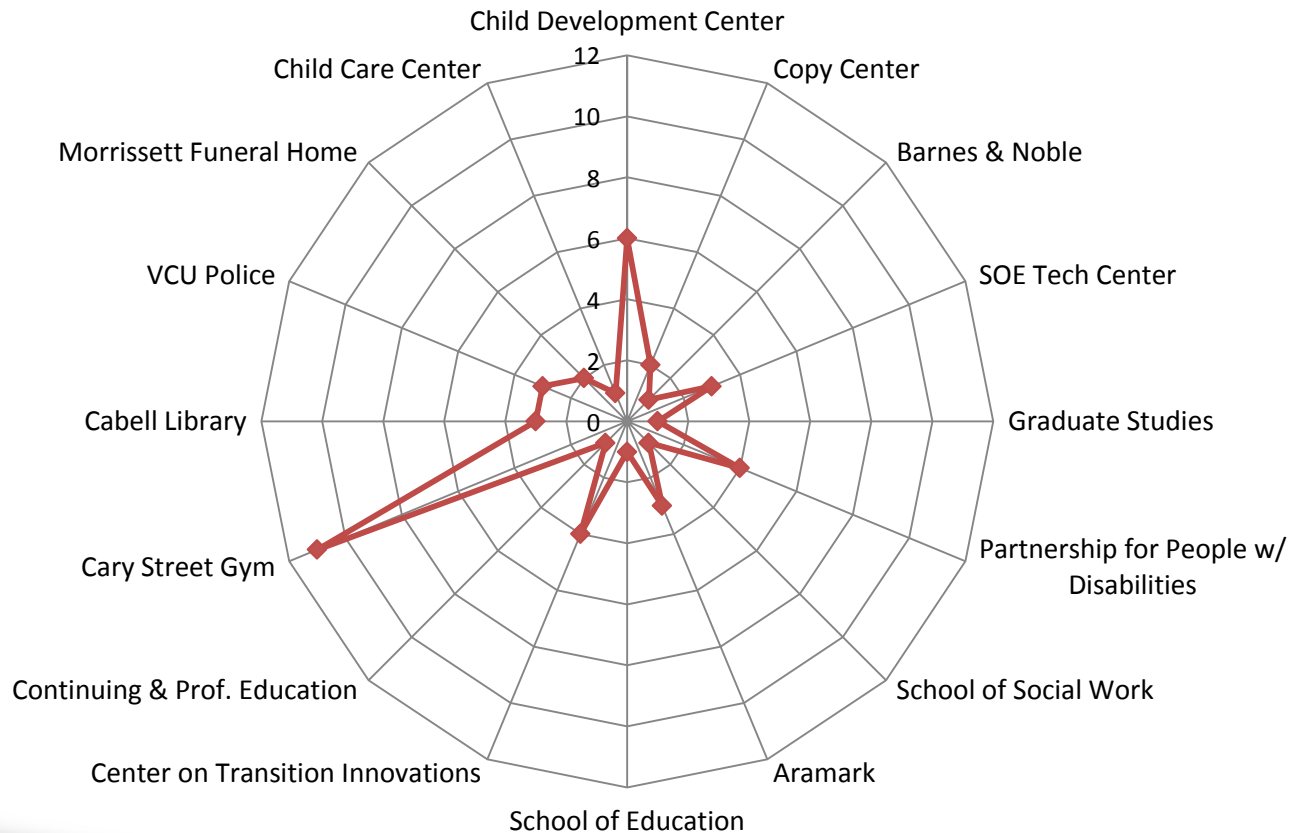

Creating a Sustainable VCU ACE-IT

- Identifying primary costs
- Education coaches education coaches
 - Trained, active VCU students
 - Provide academic support in and out of classroom
 - 10 hours per student per week
- Job coaches
- How can we sustainably cover costs required to provide needed supports?



MILESTONES

What are “Milestones”?

- A signifier of progress to a particular place or goal
- Requires knowledge of some end-state

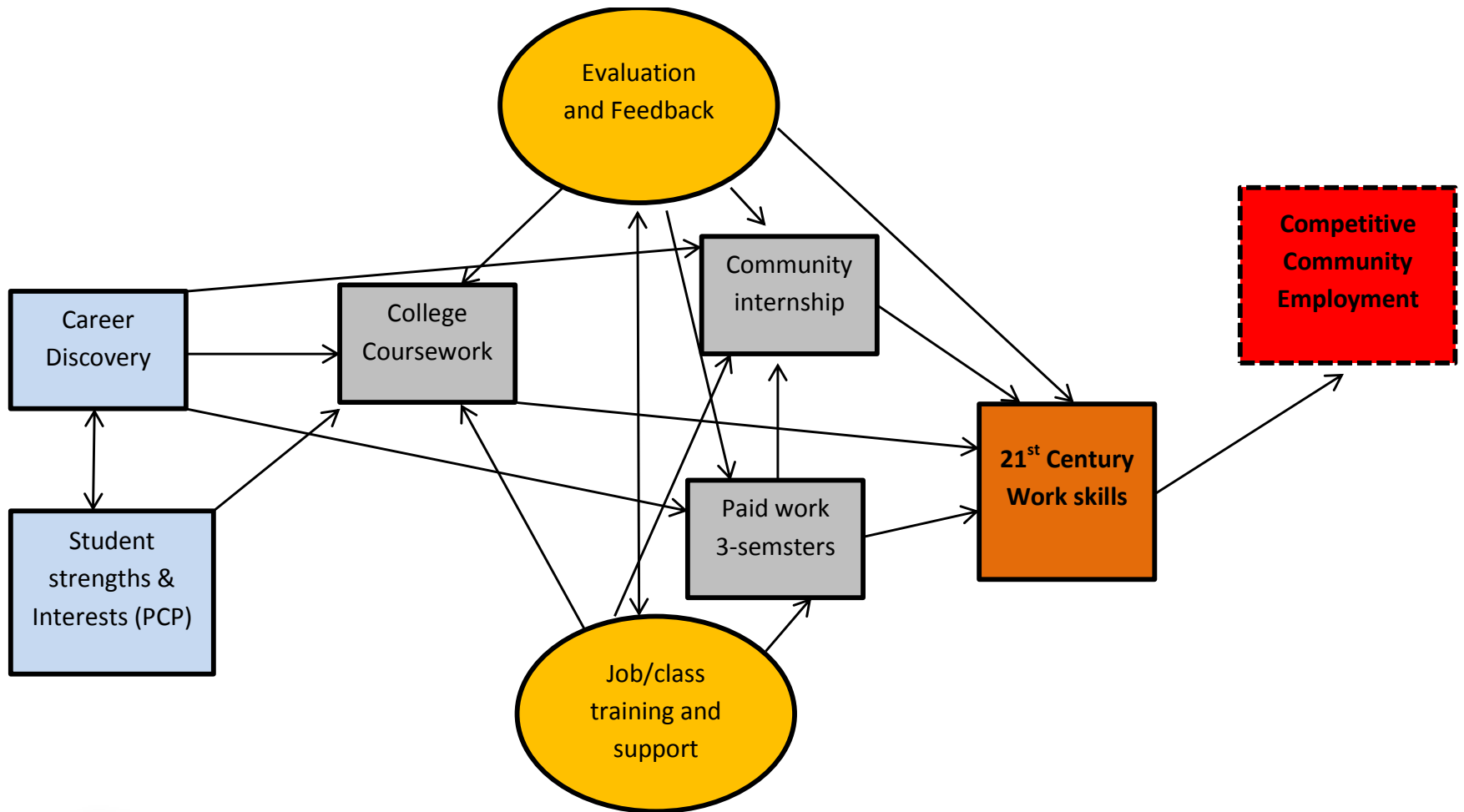


Milestone Payments

- PSE Program
 - Milestone agreement
 - Funds transferred to program IF students and staff accomplish agreed upon activities and training
 - No payment for partial completion of milestone
 - Funds covers costs of education and job coaches
 - End-states = competitive integrated employment

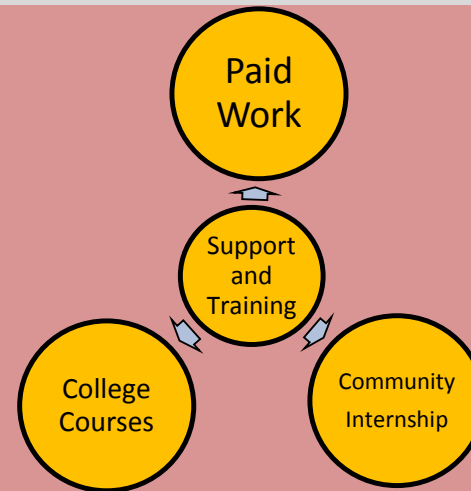

Step 2 Brainstorm

For funders?

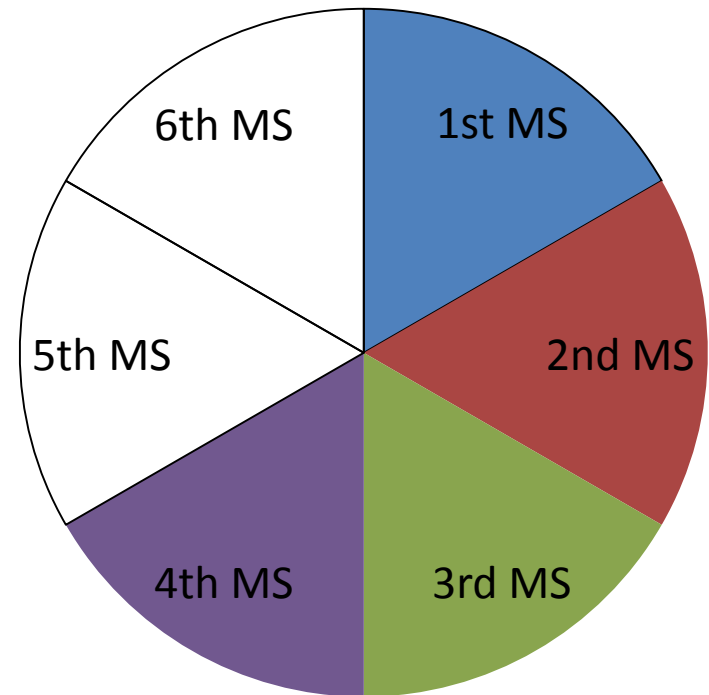
Step 3: Negotiations & MOA

- Collect evidence of program's impact
- Understand the total costs of your program with & without external funding
- Build consensus
- Clarify each party's responsibilities and reimbursement amount for successful milestone completion
- Take 5 minutes to consider impact evidence and program costs.

MILESTONE OUTCOMES

- To date, no student receiving milestone support has not completed a milestone
 - Organization
 - Motivation
- Distills a program into the most important component
- Communicates a pathway to employment for students and their families
- Sustainability

- Self-evaluating progress

Braided Funding

Models that have Sustained some PSE Program

- Non-profit status
- Concurrent enrollment
- University, college, departments
- Student/family financing
- Funds earmarked for PSE from state general assemblies
- Medicaid waiver funds
- Grants
- Peer supports/volunteerism/service learning
- Community foundations donations and private donors
- Campus partnerships, in-kind donations

Relevant Literature

PSE & Employment

- Employment training and individualized supports prepare individuals with IDD for participation in competitive employment market (Farris & Stancliffe, 2001; Grant, 2008)
- PSE programs positively impact
 - Participation in integrated competitive employment
 - Wages
 - Economic self sufficiency
 - More complex and demanding work opportunities
 - Self-determination

Adult Service Providers and PSE

- A collaboration between adult service providers and PSE program can lead to better recruitment and retention of students.
- Collaboration helps providers better understand
 - National policy
 - Program impacts on employment, quality of life, social inclusion, etc.
- 92% of agency directors (92%) from one survey believed that individuals with ID can benefit from participation in higher education (Sheppard-Jones, Kleinert, Druckemiller, & Ray, 2015)
